## Ross Garnaut: economic hit man

Climate change guru Professor Ross Garnaut is an economic “hit man”, a hired gun for the City of London bankers, whose current job is to eliminate Australia’s industrial economy through a carbon tax/trading system.

This is not a new role for Garnaut. He’s worked as an economic hit man for more than 35 years, enforcing not just Australia’s, but also Papua New Guinea’s, submission to the globalist policies of deregulation and free trade that the British Empire’s monetarist powerbrokers in the City of London dictated to the world following their take-down of the Bretton Woods monetary system in 1971.

Following is a summary of Garnaut’s record as an economic hit man, which demonstrates that his current job isn’t to solve global warming, a provable fraud anyway, but to force Australia to give over its economy to a new financial looting régime devised by the City of London, to prop up the terminally-bankrupt British globalist monetary system:

**Economic rationalism:** Garnaut is one of the cabal of economists who cooked up “economic rationalism”, the radical deregulation, privatisation and free trade policies by which Bob Hawke and Paul Keating, strongly supported by John Howard, gutted Australia’s manufacturing sector, opened Australia up to international banks and currency speculators, and transformed the economy from an industrial powerhouse to a combined raw materials quarry and highly-indebted services economy; to direct its implementation, Garnaut was Prime Minister Hawke’s principal economic adviser from 1983-1985.

**Looting PNG:** Garnaut in 1975 managed Papua New Guinea’s economic transition to independence, and set it up as a “resource-based” economy, to be forever looted by multinational mining giants such as Rio Tinto and BHP Billiton, and reduced to its present condition of being one of the poorest nations on earth. Twenty years later, he capitalised on his transition work, as chairman of both the Rio Tinto-led gold mining venture Lihir Gold (1995-2010), and BHP’s mess, Ok Tedi mining. From 1999-2002 he directed further looting of PNG as Chairman of the PNG Advisory Group on privatisation.

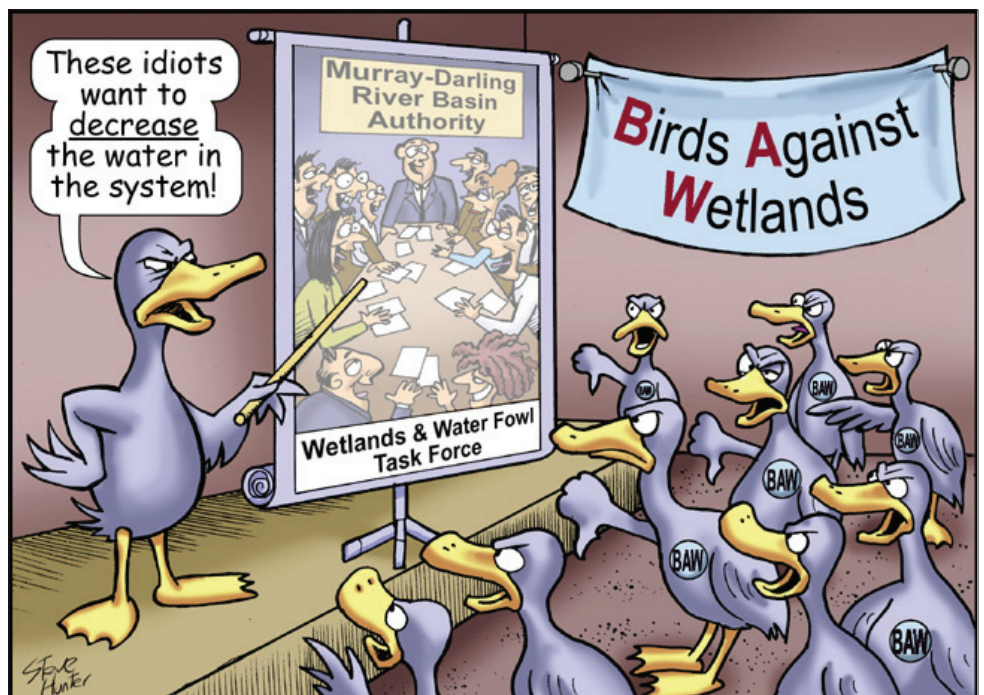
**Free trade:** Garnaut’s biggest hit on Australia was as the author of the official 1989 report which instigated the tariff cuts that annihilated Australian manufacturing, *Australia and the Northeast Asian Ascendancy*. This report was the “free trade” equivalent of his 2008 *The Garnaut Climate Change Review* for the Rudd government, similarly intended to smash Australia.

**Destroying public banks:** From 1989-1995, Garnaut directed the destruction-by-privatisation of two

publicly-owned banks, the Western Australian state bank, BankWest, and the Primary Industry Bank of Australia, PIBA. As part of the Garnaut-directed economic reforms of the 1980s, the City of London private banking cartel targeted Australia’s federal government-owned bank, the Commonwealth Bank, and all state banks for destruction, which was achieved through a combination of “scandals” and privatisations. As Chairman of BankWest and PIBA from 1989, Garnaut prepared them for sale, by ruthlessly upping their returns, thereby destroying their role as providers of credit for the community’s benefit, to make them profitable for private shareholders.

Garnaut’s latest hit man job is also being directed by the City of London. The global warming fraud was hatched in Britain by the eugenics lobby around Prince Philip, launched as a global agenda by British PM Margaret Thatcher, and turned into a money-making scam by City of London investment funds such as Generation Investment Management, the London hedge fund run by Al Gore’s Goldman Sachs partners David Blood, Mark Ferguson and Peter Harris. Finally, none other than Her Majesty Queen Elizabeth in November 2009 ordered the member nations of the British Commonwealth to submit their economies to the suicidal climate change “measures” put forward by the likes of Garnaut.

## Isherwood:

# Say 'NO' to Gillard's death panel

Citizens Electoral Council leader Craig Isherwood today called on all Australians to emphatically reject Julia Gillard's attempt to set up a "death panel" to control funding to Australia's health care system.

"Julia Gillard is flashing her Fabian knickers by seeking to copy the British NICE [National Institute for Health and Clinical Excellence] system, and Obamacare in the U.S., and place control over the life-and-death decisions of health funding in the hands of an 'independent', meaning unelected and unaccountable, commission," Mr Isherwood said.

"She made a big show of ditching Kevin Rudd's health plan, but she's actually kept the evil heart of it—the death panel.

"Our health system is abysmal now, because it is chronically underfunded, but Gillard's death panel will make it infinitely worse, by making the decision-makers unaccountable to the people whose lives are in their hands. At least when politicians make murderous decisions, the people can throw them out," he said.

Britain's NICE is murdering Poms by the thousands to drive down health care "costs", by applying its death-calculus of *quality-adjusted life years*, to funding decisions.

A quality-adjusted life year, or QALY, scores health on a scale of zero to one: zero if you're dead, one if you're in perfect health. A medical procedure moves the patient up the scale. For example, a hip replacement may move the patient from 0.5 to 0.7, an improvement of 0.2. If it is assumed the patient will live for 15 more years, those 15 actual years are multiplied by the 0.2 improvement of the QALY scale achieved by the procedure, to arrive at a calculation of three quality-adjusted life years. The total cost of the procedure is then divided by the calculated QALY, to determine the cost per QALY: if the hip replacement cost \$15,000, the cost per QALY is \$5,000.

NICE chairman Sir Michael Rawlins gave an interview to *Time* magazine on 27<sup>th</sup> March, 2009, in which he admitted, "The most controversial area is where you place the dividing line between what is cost-effective and what is cost-ineffective. That is the 'How much is life worth?' question ... *The judgment of our health economists is that somewhere in the region of £20,000-30,000 per quality-adjusted life year is the [threshold],*

but it's not a strict limit." [emphasis added]

A March 2009 *European Journal of Cancer* editorial accused NICE of basing its funding decisions not on clinical effectiveness, but on cost-effectiveness. London Oncologist and professor of cancer medicine at the Imperial College School of Medicine Dr Karol Sikora wrote in the 12<sup>th</sup> May, 2009 *New Hampshire Union Leader*, "As a practicing oncologist, I am forced to give patients older, cheaper medicines. The real cost of this penny-pinching is *premature death for thousands of patients*—and higher overall health costs than if they had been treated properly". [emphasis added]

Mr Isherwood called on every Australian to act to stop Gillard's plan: "Fight this as if your life depends upon it, because it does. And deliver the message to your state and federal MPs that their political futures depend upon them defending the lives of their constituents, by rejecting this plan."
