Lest we forget... the British policies that killed Australians

60,000 Australians were killed in WWI. They were brave men who volunteered to fight, and whose courage and willingness to sacrifice deserves to be venerated.

But what were they fighting for?

Unfortunately, there is often a difference between what soldiers *believe* they are fighting for, and what they are actually fighting for. For example, in Iraq the soldiers and the public who supported them were told they were fighting to save the world from Saddam's weapons of mass destruction, but not only didn't those weapons exist, British leader Tony Blair knew they didn't exist, because it was his office that invented the lie used as the final excuse to attack.

Blair had an agenda: changing international law to overturn the Westphalian principle of national sovereignty and the right of non-interference, in favour of legalising the principle of preventive war, used by Hitler to invade Czechoslovakia.

In WWI Australian soldiers were not fighting to defend Australia. They were fighting for the British Empire, in a war that was personally organised by the King of England, Edward VII, against his nephew, Kaiser Wilhelm II. They were pawns in an imperial strategy, which unhesitatingly sacrificed the lives of millions to pursue the interests of the elite financiers of the City of London who directed the British Empire. At Gallipoli, 8,000 Australians were sacrificed by Britain's imperial chess-masters, such as Winston Churchill, to whom the Australian, New Zealander and British soldiers were cannon fodder.

A key strategy of the British in WWI was the takeover of the oil fields of the Middle East from the Ottoman Empire. While France suffered 1,500,000

deaths and 2,600,000 wounded bearing the brunt of the fighting with Germany on the Western Front, Britain poured an incredible number of its own troops—over 1,400,000, including Australians—into the Eastern Theatre, the Middle East. Britain entered into a secret pact with France in 1916, the Sykes-Picot Treaty, which carved up the Middle East between them, betraying their promise of sovereignty made to the Arab tribes mobilised by Lawrence of Arabia to fight the Turks.

“The Arab inspiration was our main tool for winning the Eastern war,” Lawrence wrote. “So I assured them that England kept her word in letter and spirit. In this comfort they performed their fine things; but of course, instead of being proud of what we did together, I was continually and bitterly ashamed.”

Many Australian soldiers returned from WWI completely disillusioned with the British Empire. Media liars such as Keith Murdoch marginalised them, and questioned their patriotism. Murdoch launched a media propaganda campaign, to stop Australians from questioning our subservience to the British Empire, and the Crown. That propaganda campaign has continued to this day, and it is wheeled out every Anzac Day, even more heavily in recent years.

Lest we ignore... the British policies intended to kill Australians

The carbon tax—more British genocide

It is time for Australians to not just question our subservience to the British Crown, but to end it.

Virtually all of the economic policies that have destroyed Australia over the past three decades have been British:

- the 1983 float of the dollar, organised by British bank Hill Samuel (now Macquarie)
- the free trade tariff cuts that gutted manufacturing; the privatisation of public assets, directed by Rothschild and Macquarie
- National Competition Policy, written and enforced by Macquarie Bank, which has annihilated small independent producers and retailers and massively expanded the businesses of Coles and Woolworths.

The latest British policy designed to destroy Australia is the carbon tax; in fact, the whole global warming hoax. Australians despise the carbon tax, and it will mean the end of Julia Gillard's government, but she is pushing ahead with it because she is under orders... from the Queen. Queen Elizabeth ordered the Commonwealth nations—her “former” empire—gathered at Trinidad and Tobago for the Commonwealth Heads of Government Meeting (“**CHOGM**”) in November 2009 to “lead” the world on addressing climate change.

The current imperial strategy being pursued by the Queen is, in a word, *genocide*. As stated repeatedly by her husband, Prince Philip, the British Crown intends to *reduce* the world's population from its present 6.7 billion down to less than two billion. Crown minions in Australia, notably Professor Tim Flannery, a trustee

of Prince Philip's World Wide Fund for Nature and a patron of Sustainable Population Australia, insist Australia's population should be slashed to as low as 6 million.

The British Crown fostered the post-war rise of environmentalism, not to achieve “conservation” of nature, but to target human activities for destruction. Greenies have been deployed to stop economic development, shut down industries, and cook up international treaties to override our national laws, and sovereignty. The industries and developments that they target are essential to support our living standards, and lives—witness the current, ferocious shut-down of Australia's most important food source, the Murray-Darling Basin, by Prince Philip's eco-fascists.

Julia Gillard's carbon tax will cause mass-deaths in Australia, and its designers know it. Forget the financial cost, it will cripple the physical generation and supply of electricity, causing blackouts and brownouts. Even if pensioners and the poor could somehow pay the sky-high prices, more often than not when they flick their switches there won't be any power.

Australia has already experienced a rise in fatalities during heat waves and cold snaps, such as the 374 deaths of senior citizens in the Melbourne heat-wave the week before the Black Saturday bushfires, and under the carbon tax such episodes will increase, combined with an increase in deaths from diseases of poverty, such as respiratory illnesses.

Be a patriot, fight for Australia's future

In January, Citizens Electoral Council leader Craig Isherwood declared war on the British Empire. He laid out the CEC's intention to rid Australia once and for all of the British policies that have destroyed us, the economic policies that have looted our wealth, and the green policies that have annihilated our industries.

Mr Isherwood announced the CEC's plan to re-establish a national bank like the original Commonwealth Bank, so that Australia can take control of its own credit, take control away from the City of London, and use that credit to launch a national program of economic development, centred:

- large-scale water, power and transport infrastructure, and

to revitalise Australia's economy and give our children and grandchildren a prosperous future.
