## Anglicans side with Satan, Prince Philip to destroy Murray-Darling Basin food bowl

“Even with the help of Prince Philip, Satan himself could not have issued a more vicious attack on humanity than did the Anglican Church Environment Working Group in its recent statement, *The Sustainable Conservation and Use of Australian Water Resources with particular reference to the Murray Darling Basin*”, proclaimed CEC national leader Craig Isherwood today.

“Cloaked in pseudo-Christian rhetoric about how ‘God is sovereign over His Creation’, and that ‘the Christian message is one of hope’”, Isherwood said, “the Anglicans in fact call for a drastic reduction in water for irrigation via their astounding claim that it is the greedy farmers—the ones who in fact have developed this world miracle of irrigation—who are destroying the Basin: ‘Whether the people and creatures of the Basin flourish or not depends on the extent and distribution of rainfall within the Basin, and the just use of this resource. *The ever-present issues of greed and pride and their consequences, that beset human endeavour*, must not be allowed to overwhelm our commitment and hope of seeing all creation, plants, animals and people, flourish.’

“These guys are so nauseatingly pious they would make even the Devil retch,” Isherwood continued. “In fact, the Anglican statement excoriates *actual* Christianity—that human beings by virtue of their *unique powers of human creative reason* are created in the image of God the Creator to ‘have dominion over the earth’, *exactly as has been done in the Basin*. Instead, these Anglican fruitcakes pronounce that ‘The defence of those unable to speak for themselves, whatever form they take, has always been part of the church’s business and we would wish to stand with those who are now struggling with the consequences of past policies and farming practices.’

“What crap!

“You want to know what’s going on here?”, asked Isherwood rhetorically. “It’s the same old, same old: The Anglicans are just lying toadies for Prince Philip, as usual, just as with their viciously anti-human submission to the Sustainable Population Strategy inquiry last year. As our October/November 2011 issue of the *New Citizen* exhaustively documents, it was Prince Philip, the Royal Virus himself, who created the WWF, the ACF, the Ramsar Convention on Wetlands and all the other major Green Fascist institutions that have long crusaded to shut down the Basin, on behalf of his oft-proclaimed intent to reduce the world’s population from its present seven billion down to one billion or

less. And of course this genocidal maniac just happens to be the consort of the head of the Anglican Church, Queen Elizabeth.

“You think these oh-so-holy Anglicans are concerned in the slightest about the countless human lives which will be lost or destroyed if the present plans to slash irrigation go ahead?!” Isherwood exclaimed. “With their gnostic, actually pagan version of Christianity, they claim that they are standing up for the plants and animals in the Basin who can’t talk. Just on that account, were they even mildly honest, they would acknowledge the reality: that the development of the Basin has enabled a far greater quantity of plants and animals to flourish, than if the Basin were left in its undeveloped state of large tracts of desert. Not to mention that the Basin has been developed over a century with one intention: the natural human inclination to provide for the ‘common good’, in this case to feed tens of millions of human beings in Australia and beyond, who are all God’s children, each of whose life is therefore sacred.

“But I’ll tell you how slimy these Anglicans are”, Isherwood continued. “The Anglican Church hierarchy is fully aware that this kind of pro-Green paganism spits in the face of actual Christianity. So what they did is they set up this Environment Working Group which trumpets all its ‘findings’ and ‘position papers’ under the official title of the ‘Anglican Church’. So you think it is all official Anglican Church policy. But just in case someone nails this stuff for the anti-Christian filth it is, in order to cover their wildly exposed behinds the Anglican bosses stick in a disclaimer down at the bottom in fine print, literally in a footnote at the end of the documents released by this Anglican ‘Working Group’: ‘The Environment Working Group is empowered to release discussion papers under its own authority. It is an advisory body for the Anglican General Synod Standing Committee and does not carry the authority of the Anglican Church of Australia.’

“The Anglican hierarchy would make the Pharisees blush!” concluded Isherwood in disgust. “But if you want to fight to save the lives and livelihoods of tens of thousands of precious human beings in the Basin, and the food supply of countless millions more, then you’d better tell the truth: This is all coming from the British Crown, and solely for the purpose of mass murder on a scale to dwarf Hitler’s wildest dreams. And if you’re an Anglican, you’d better go ask your ministers what the Hell they think they are doing.”

## Regulators must stop covering for bankrupt banks

Isherwood: The ongoing cover-up of the actual bankruptcy of Australia's major banks and financial institutions, by the regulators who are supposed to police those institutions, is a crime that must be stopped now, Citizens Electoral Council leader Craig Isherwood said today.

Isherwood was responding to the revelation that Australia's bank regulator, the Australian Prudential Regulation Authority (APRA), had refused a *Sydney Morning Herald* FOI (Freedom of Information) request to release its "risk registers" of Australia's leading financial institutions. The 27<sup>th</sup> December *Sydney Morning Herald* reported that APRA's general counsel, Warren Scott, advised against the release on the grounds that releasing the information "may affect the stability of Australia's economy".

Isherwood accused APRA, the banks and the government of colluding to keep the public ignorant of the true state of Australia's supposedly "sound" financial system.

"The APRA revelations are no surprise to the CEC, because for close to two decades we have known and reported that Australia's banks are bankrupt," he said.

"APRA's behavior is an insight into how desperate the government, the banks and the regulators are to keep the truth from the public."

Isherwood recounted how Australia's other regulator, the Australian Securities and Investments Commission (ASIC), in 2005 threatened the CEC when its June 2005 *New Citizen* newspaper headlined "Mother of All Bubbles" [Go online to read more: <http://cecaust.com.au/main.asp?sub=pubs&id=nce06-05.htm>] reported how heavily Australia's banks were exposed to dangerous derivatives financial instruments—the very derivatives that later bankrupted Lehman Brothers and blew out the global financial system.

ASIC threatened to charge the CEC's directors for giving financial advice without a licence.

Isherwood continued, "ASIC—the same regulator that later let the Commonwealth Bank and Storm Financial prey on vulnerable people and destroy their lives [Go online to read more: [http://cecaust.com.au/main.asp?sub=releases&id=2009\\_02\\_06\\_Storm\\_Financial.html](http://cecaust.com.au/main.asp?sub=releases&id=2009_02_06_Storm_Financial.html)]"—threatened the CEC for showing the banks were in trouble in 2005, yet, crimi-

nally, the *Sydney Morning Herald* FOI request revealed that APRA didn't compile risk registers on the banks until after the GFC erupted in September 2008.

"The CEC's case proves the regulators were well and truly warned in advance. And they shouldn't try to hide behind the bureaucratic excuse that ASIC and APRA are different agencies—the CEC distributed 300,000 copies of that same *New Citizen* exposé nation-wide."

The issue, Isherwood said, is that since the globalisation "reforms" of Hawke and Keating, the Australian financial system has been exposed to the same legalised stealing by banks that has bankrupted the rest of the world, but the government, regulators and banks are trying to cover up the fact that Australia is in the same mess.

He said, "Instead of admitting the problem, the government is desperate to stick with the policies that caused it, because those policies give their financial masters in the City of London banking system the power to dictate to nations.

"The major parties are not screaming about this, because they are no more than lobbyists for the financial interests of the private banks; instead of protecting the people, they are sacrificing the people to maintain the power of the banks.

"The CEC is the only institution in Australia with credibility on the financial system, because all along our sole concern has been to return to the kind of financial system that served Australia so well during WWII, when the Commonwealth Bank—our national bank—directed the banking system to serve the needs of the nation and the people."

Isherwood concluded, "It's time to stop covering up the banking crisis, and address it. The CEC would put the entire financial system into receivership to sort out the bankruptcy, and establish a Pecora Commission [Go online to read more: [http://cecaust.com.au/main.asp?sub=releases&id=2009\\_01\\_20\\_Pecora%20\\_Press.html](http://cecaust.com.au/main.asp?sub=releases&id=2009_01_20_Pecora%20_Press.html)] to clean out the corruption between the banks, regulators and government.

"Most importantly, the CEC would establish a new national bank that can direct as much credit as the nation needs to put everybody into productive work, building infrastructure, and creating high-skilled jobs in expanded agriculture and manufacturing industries. There's no limit to the amount of credit a national bank could issue, if we have the manpower and materials to put to work."
