Australia Needs More People—Not “Population Control” Genocide!

Australia is an empty and totally underdeveloped continent. Under the prevailing free-trade policies, we have shut down our manufacturing, destroyed our family farmers, and concentrated what little infrastructure we have into the coastal cities. Mining is left to large foreign owned multinationals who pay as little as 3.75 per cent in ‘trinket’ royalties to steal our wealth. Over the last 40 years of economic rationalism and globalisation we have failed to maintain basic economic infrastructure, such as health care at 1960s per capita levels, and then the predictable disasters ensuing from this failure are conveniently blamed on “increasing population”, which is merely a fraudulent pretext for *intentional* policies of genocide, masked under the euphemism of “population control”.

Isolated rural towns and communities, which were reliant on the now collapsing or non-existent agricultural production are being ruthlessly denuded of people, with most moving to the cities, and the vast areas of northern Australia with its potential to support 100 million people is left empty.

Australia, currently with a population of 22 million, has a population density of 2.9 people per square kilometre (/km²)—the 3rd lowest in the world behind Mongolia, and Namibia in West Africa! By contrast, our iconic suburbs of Eastern Sydney, like Manly and Bondi, have a population density of 6,900 / km²—2,400 times greater than Australia’s average population density. Tasmania today, even with its vast wilderness areas, has a population density of 7.4 /km² (2½ times greater than Australia), which if emulated on the mainland would give Australia a population of 57 million people—with huge amounts of empty space still to be developed.

With the planned development of regional Australia, using ideas such as Professor Lance Endersbee’s High Speed Australian Ring Rail, the development of many of our river systems, and with nuclear power, the myth of potential “overpopulation”, would evaporate as an obvious fraud. In fact, if we actually intend to develop our vast continent, then we need a rapidly growing population.

But this means dumping the prevailing policies of British-led globalisation, free trade, economic rationalism and privatisation of state-owned assets, championed by the major parties. These policies are just plain City of London-centred British imperialism, a genocidal continuation of that Empire’s opium and slave trading activities of yesteryear. The intent is identical: to obliterate nation states by denying their physical economic means of existence, and by treating human beings as cattle.

If these disastrous policies are not dumped, then under the deepening systemic breakdown of the global financial and monetary system, which is exemplified by the current

events in Greece, Australians will not be immune from Prince Philip’s publicly stated desire to see the world’s population collapse from nearly 7 billion people to less than 2 billion. The genocidal dreams of Prince Philip adherent and “population control” fanatic Kelvin Thomson will come true, but you yourself may well be on the death list! [See over page.]

A real “population policy” has to begin with Lyndon LaRouche’s Four Powers Agreement, to put the world’s financial and monetary system into immediate bankruptcy reorganisation, and to return to policies of national sovereignty with large nation-building physical economic infrastructure projects. This is what U.S. President Franklin Roosevelt had intended in his design of the original Bretton Woods agreements in 1944, before they were overturned by his successor, President Harry Truman and Truman’s controller Winston Churchill. Roosevelt had planned to eliminate Empires; to use National Banking to create sovereign credit; and to promote the development of perfectly sovereign nation states through very large-scale infrastructure development like that of the Tennessee Valley Authority development, or our own Snowy River Scheme. With the global financial collapse deepening by the day we must, at long last, dump the British monetarist imperialism administered from London and Wall St., and return to Roosevelt’s dream for the postwar world, a dream shared by such greats of “old Labor” as John Curtin and Ben Chifley.



Adapted from Prof. Lance Endersbee’s Australian Ring Rail proposal of 1997 we can expand the potential of developing Australia by criss-crossing the country with high-speed rail—preferably the latest generation Mag-lev technology. Combined with the latest generations of high temperature modular helium-cooled pebble bed nuclear reactors and large scale water projects around the country, we can transform Australia into an agricultural and industrial power-house once again. Hence, we will need more people!

“Population Control” is Genocide!

• Kelvin Thompson, former President, Australian Fabian Society, *Wills Report*, December 2009:

“Population projection for Australia and the world are too high and unsustainable. **I believe global warming, water shortages, food crisis, overcrowded cities, transport congestion, species extinction, waste, housing affordability, rising cost of living war and terrorism are all either caused by or exacerbated by rising population.**”

“Recent projections indicate that Australia’s population will reach 35 million by 2050. If this is allowed to happen it will mean Melbourne will almost double and reach 7 million people, Sydney will become a city of 7 million people and Brisbane could double to four million. **This will have devastating effects on our ability to tackle climate change and protect our unique wildlife and ecosystems. I am of the strong belief that Australia must be moving to stabilise population in order to secure its social, environmental and economic future.** Rather than sleepwalk into an environmental and social disaster, I have put forward a 14 point Population Reform paper that sets out how we can stabilise our population at 26 million by 2050.”

• H.G. Wells, founder, British Fabian Society, *Anticipations of the Reaction of Mechanical and Scientific Progress upon Human Life and Thought*, 1902:

“The first chapter in the history of this intellectual development, its definite and formal opening, coincides with the opening of the nineteenth century and the publication of Malthus’s *Essay on Population*. Malthus is one of those cardinal figures in intellectual history who state definitely for all times, things apparent enough after their formulation, but never effectively conceded before. He brought clearly and emphatically into the sphere of discussion a vitally important issue that had always been shirked and tabooed heretofore, the fundamental fact that the main mass of the business of human life centres about reproduction. Probably no more shattering book than the *Essay on Population* has ever been, or ever will be, written. **It made as clear as daylight that all forms of social reconstruction, all dreams of earthly golden ages must be either futile or insincere or both, until the problems of human increase were manfully faced...**”

Malthus “awakened almost simultaneously in the minds of Darwin and Wallace, that train of thought that found expression and demonstration at last in the theory of natural selection. As that theory has been more and more thoroughly assimilated and understood by the general mind, it has destroyed, quietly but entirely, the belief in human equality which is implicit in all the ‘Liberalizing’ movements of the world. **It has become apparent that whole masses of human population are, as a whole, inferior in their claim upon the future, to other masses, that they cannot be given opportunities or trusted with power as the superior peoples are trusted...**”

“While the New Republic is gathering itself together and becoming aware of itself, that other great element, which I have called the People of the Abyss, will also have followed out its destiny. For many decades that development [i.e. population growth – Editor] will be largely or entirely out of human control. To the multiplying rejected of the white and yellow civilizations there will have been added a vast proportion of the black and brown races, and collectively those masses will propound the general question, ‘What will you do with us, we hundreds of millions, who cannot keep pace with you?’ If the New Republic emerges at all it will emerge by grappling with this riddle; it must come into existence by the passes this Sphinx will guard.”

“**And how will the New Republic treat the inferior races? How will it deal with the black? How will it deal with the yellow man? How will it tackle that alleged termite in the civilized woodwork, the Jew? ...And for the rest, those swarms of black, and brown, and dirty-white, and yellow people, who do not come into the new needs of efficiency? Well, the world is a world, not a charitable institution, and I take it they will have to go. The whole tenor and meaning of the world, as I see it, is that they have to go. So far as they fail to develop sane, vigorous, and distinctive personalities for the great world of the future, it is their portion to die out and disappear.**”

“The new ethics will hold life to be a privilege and a responsibility, not a sort of night refuge for base spirits out of the void; and the alternative in right conduct between living fully, beautifully, and efficiently will be to die. For a multitude of contemptible and silly creatures, fear-driven and helpless and useless, unhappy or hatefully happy in the midst of squalid dishonour, feeble, ugly, inefficient, born of unrestrained lusts, and increasing and multiplying through sheer incontinence and stupidity, **the men of the New Republic will have little pity and less benevolence. The men of the New Republic will not be squeamish, either, in facing or inflicting death, because they will have a fuller sense of the possibilities of life than we possess. They will have an ideal that will make killing worth the while; like Abraham, they will have the faith to kill, and they will have no superstitions about death.**”
